Pachchigar Homoeopathic Medical College, Near Anand Mangal Society, Bhatar Road, Majura, Surat, Gujarat with admission intake capacity of 100 seats for Undergraduate (BHMS) course and 37 seats for Postgraduate Course [MD(Hom.)] Organon of Medicine (06 Seats), Materia Medica (06 Seats), Pharmacy (06 Seats), Repertory (06 Seats), Practice of Medicine (06 Seats), Paediatrics (03 Seats), Psychiatry (04 Seats) for academic year 2023- 24: reg.

Sir,

C.D. Pachchigar Homoeopathic Medical College, Near Anand Mangal Society, Bhatar Road, Majura, Surat, Gujarat is functional since 1982 has submitted an application for permission for sanction of 100 seats in BHMS course and 37 seats for Postgraduate course for the academic year 2023-24. The College has submitted the Part 1 information in which the entire functional profile has been narrated. Medical Assessment and Rating Board for Homoeopathy (MARBH) has examined the profile of the College as to whether the college fulfils the essential standards to be fulfilled as per the prevailing regulations under NCH Act, 2020.

MARBH has examined the application and observes that the College shall fulfil the following functional requirements as per the required minimum standards:

(a) **For College:**

- Documents of the following Faculties such as Qualification, experience and Letter of appointment & joining and attendance for last 03 months shall be submitted for verification:
 - i. Dr. Vismay Rajendrabhai Prajapati, Department of Organon of Medicine
 - ii. Dr. Shilpa Sudhakar Mehkarkar, Associate Professor, Dept. of Paediatrics
 - iii. Dr. Snehaben Pruthviraj Talaviya, Assistant Professor, Dept. of Organon of Medicine
- Form 16 from Traces Portal for all Staff shall be submitted for verification.
- Biometric attendance of all staff shall be submitted for verification.

(b) **For Hospital:**

- Case Sheet with name, age, sex, address and contact phone no. of patient, presenting Complaints, prescription, referral/IPD admission with signature of the consulting doctor etc. is not submitted. IPD and OPD cases (12 cases OPD and 12 cases IPD for last one year) shall be submitted for verification.
- Case records should be maintained with demographic details of the patient such as name, age sex, address, phone number etc.
- Case sheets shall be maintained with complete case analysis and evaluation and repertorisation and made available in the medical record room for academic purposes of students.
- Lab investigation report should be maintained properly in case records.
- All follow-up attendance should be recorded on the case records.
- Disease diagnosis shall be recorded in all case records as per ICD 11 criteria.

- (c) **Other documents:** Audited statements for the College and Hospital for the College and Hospital for 2022-23 shall be submitted.

The above shortfalls observed in your College shall be rectified within a period of 15 days and the compliance report shall be submitted to the MARBH. Considering the above observations, and facilities available, MARBH has decided to issue **conditional permission to C.D. Pachchigar Homoeopathic Medical College, Near Anand Mangal Society, Bhatar Road, Majura, Surat, Gujarat with admission intake capacity of 100 seats for Undergraduate (BHMS) course and 37 seats for Postgraduate Course [MD(Hom.)] Organon of Medicine (06 Seats), Materia Medica (06 Seats), Pharmacy (06 Seats), Repertory (06 Seats), Practice of Medicine (06 Seats), Paediatrics (03 Seats), Psychiatry (04 Seats) for academic year 2023- 24.**

It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 100 UG seats and 37 PG seats shall be treated as All India Quota. The counseling for seats under All India Quota shall be conducted by respective counseling authority of State/UT Govt. as designated by Central Government/NCH for the A.Y. 2023-24 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCH for All India Quota or the students admitted thereunder.

All admissions shall be made from NEET & AIAPGET qualified candidates only. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Govt. for All India Quota or the student admitted thereunder. The category wise list of the selected candidates may be informed to the MARBH after the process of admission is completed.
